Skim Milk Powder is made from fresh whole milk which has been separated, standardised, heat-treated, evaporated and spray dried.

PRODUCT APPLICATIONS

The Union Dairy Company High Heat, Heat Stable Skim Milk Powder can be readily used in a wide range of applications such as stored hot beverages, recombined evaporated milk, recombined sweetened condensed milk, coffee whiteners and bakery products.

PACKAGING

Packaged in a multiwall bag with a paper outer and a gas barrier plastic inner liner. Bags are packed on a pallet, in a 72 bags per pallet configuration.

CODING

Bags are Individually labelled with:

- Factory registration number,
- Bag number,
- Date of manufacture (DD/MM/YYYY),
- Date of expiry (DD/MM/YYYY) and
- Batch number (YYYY/MM/DD).

STORAGE AND HANDLING

It is recommended that powder is stored at or below 25°C, relative humidity below 65%, out of direct sunlight and in an odour free environment. While the bag is intact and storage conditions are met, the powder has a shelf life of 24 months from the date of manufacture.

ALLERGEN STATUS

Contains milk and milk products.

INGREDIENTS

Fresh heat-treated skim milk derived from healthy cows' milk.
